

1.	Fill Visa Application Form (Mandatory to fill applicants email id & mobile #) with Signature Attach 2 Photographs (Size 5.5 cm X 5.5 cm) with white background
2.	The travel document should be valid according to the studies and not less than 6 months (recommended 09 months) Passport must have at least 2 blank pages Approval from Ministry of Interiors, Israel is Mandatory
3.	Must Submit ALL PASSPORTS that you hold (including current/old/cancelled/expired/ special)
4.	Must enclose the following documents and details: - <ul style="list-style-type: none"> a) Covering Letter from the Applicant for the travel (In Original) mentioning - Name, Passport No., Purpose of travel, Duration of stay and signed by applicant with contact details. b) NOC from both the parents along with photocopy of their Passport (1st & Last Page), if do not have the passport submit a declaration from both the parents with their NIC card copy. (In case one of the parent is expired then death certificate copy is required. c) If associated with any Organization/ Institute, then need to provide the NOC from there with contact details of the signing authority (Original). d) Invitation Letter from the Spouse based in Israel. e) Copy of Passport (1st and Last Page) & current valid visa of holder as well as the first visa for the spouse. f) Updated Invitation letter from the Academic Institute/University of invitee for the family members (Letter should be issued from the administrative department). g) Proof of accommodation in Israel. h) Travel Ticket –Booking (NOT CONFIRMED TICKET). i) Travel and Health insurance both required (same is available at VAC). j) Photocopy of NIC Card & Current valid Passport (1st & Last Page) k) Immigration approval (You have to bring all your passports, current and previous to get a letter from IVS.

IMPORTANT REMARKS

1. Submit all the above-mentioned documents Only in A4 size and not in back-to-back format.
2. If married, then passport should be updated with the spouse name as well as the spouse passport also to be updated with the spouse name. **Also, submit Original Marriage Certificate attested by MFA.** (If Marriage Certificate can be tracked online on official (govt.) website then Attestation by MFA on certificate is not required).
3. **If the applicant is traveling together with their spouse, and that spouse is already a student in Israel, then NO prior approval from Israel's Ministry of Interior is needed.**
4. **If the spouse (who is a student in Israel) is already staying in Israel, then the applicant (A/4 dependent) does need prior approval from Israel's Ministry of Interior.**
5. **IN CASE OF MINOR ACCOMPANYING PARENTS: -**
 - a) Need original Birth Certificate attested by MFA.
 - b) Parents (Father & Mother) need to visit IVS at the time of submission for signing the Minor consent form
 - c) In case one of the parent is not in India then he/ she must sign the Minor consent form at Embassy of Israel in that particular country.
6. Embassy may ask for additional documents or request for the Interview.
